Central Budget

- Canada Summer Jobs
 - o add 2 positions to budget in case grant is awarded
- Discussion over possible move from 205 Regina to happen this year

ED Budget

Nothing changed from last year

President budget

- Changed to Summer Workshops instead of Camp to save money
- NASH location is up in the air was supposed to be Ottawa but may have switched

Finance Budget

Summer fees lowered

Advertising Budget

- Mat Leave job posted, hoping to hire in June
- Chamber of Commerce membership removed as did not see value
- Ad Sales setting safe goals and achievable for the incoming hire
- Should we have annual ad fee increases?
 - o Cord ad rates were increased quite high when Care first started
 - o Lower circulation and campus than UW Imprint but rates are the same
 - o Raised the web fees 3 years ago, it hasn't changed client bookings
 - Radio Laurier rates could also be looked at to increase

Human Resources Budget

• VA – we don't actually spend that much due to advertising deals however we'd like to be prepared

Community Edition Budget

- Steel Rails expected to be even more profitable this year due to venue change
- Remove Line 110: TCE Mixer as not happening again
- TCE has a strong increase in ad revenue especially in the context of expenses

Cord Budget

- News Director to be hired this summer
 - Covering the online content and prepping the incoming News Team
 - o EIC not as strong for News and Sports
 - o \$14/hour for 7 hours a week for P1, goes up to 15 hours a week for P2 or P3

- Do we want to have the most people making the publication strong throughout the year?
 - News Director is leaving in January would we rehire?
 - o May be covered by Canada Summer Jobs depending on grant
- Honouraria Some positions not existing next year
- Web Director changed to 7 hours a week instead of honouraria amount
- Removed 126 for "Food for Production"

Blueprint Budget

Lowered to 1000 circulation, 2 issues per term

Brantford Budget

BMO position removed and sputnik hired at 15 hours / week

Distribution Budget

Rack Maintenance increased to \$1000 to work on Laz Hall position

Sputnik Budget

EIC position to 15/week

Print changed to Monthly instead of bi-weekly

Revenue wise might be helped by monthly as it may have more value for clients

Radio Laurier Budget

- Station Manager to not be hired for the summer and instead starting in August
- Stream On changes to \$460/term

LSP Budget
