• Blueprint's next "Dreamer"-themed mini-issue in the works, won't be full magazine format for this issue. Blueprint held launch party for new issue at Revive on Jan 25. Housecat and Cynthia Fay concert held on Jan 26 at Veritas.

o Cord, Sputnik and Radio Laurier merch have all been delivered. WLUSP t-shirts and windbreakers have also come in—will help people recognize us at campus booths or events. Sputnik hoodies ended up \$100 over budget due to miscalculation.

- NASH Feb. 16-18 in Edmonton, 15 people going. All tickets, hotel rooms and flights have been purchased. Info on rooms and flights distributed. Aaron and I coordinating transportation to and from airports.
- Two applications for President and one for Board of Directors received, hoping for additional board applications in next week. With two Presidential candidates, have reintroduced online and advanced voting this year.
- This was production week for The Sputnik and The Cord. Next week will be busy with elections and AGM, but we have plan of action, will be rewarding to get through.

## 7.0 Executive Director Report Presented by Aaron Waitson

## **Web Manager Proposal**

- Expansion of Web Manager Sam Nabi's responsibilities approved in last board meeting,
   but board asked to learn more about what specifics Sam is looking for. Making Sam
   permanent, part-time, salaried staff member would:
  - Make him a permanent department head, allowing him to be a part of department head meetings. Web Manager role more directly involved in WLUSP's creative goals, more regular contact with other members.
  - Encourage future growth of 'Web' department→ space, resources and opportunity
    to create volunteer roles and recruit students, including a different demographic of
    students (Computer Science and UX Design programs).
  - Give Sam more freedom to evolve the Web Manager role, branch out into advocacy/networking with other publications on behalf of WLUSP, and share his knowledge of web and digital media strategy so we can adapt to current digital landscape.

Allow Sam and Administration to have more thorough performance evaluations,
 allow him to assist with succession planning.

#### **Vacant Community Director Position**

- After searching, Brit Kovacs suitable replacement for Community Director vacancy, and she has expressed official interest.
- Board expressed interest in Brit joining at last board meeting, but official decision not reached.
- Given Brit's wealth of previous experience, passion for the organization, and involvement in Waterloo Region community, I continue to support her nomination as a candidate. We can vote on this today.

#### WLU'er Publisher Responsibilities

- This year WLU'er saw its most successful distribution numbers ever (100%, 4000 copies), but Advertising department struggled to sell enough advertising space due to tight timeline for production. Moving forward, would be valuable for advertising sales to begin earlier in the year than the summer term.
- As it stands, advertising team cannot begin selling space for publication to clients until a
  number of details are confirmed—details that can only be approved by incoming
  President and Publisher (not current President, given WLUer's fall publishing date). As a
  result, production is halted until May.
- Proposing that WLU'er publisher responsibility be shifted from President to Executive Director. This way, important preliminary decisions for handbook could be made before May.
- Executive Director could more directly assist in planning and creative aspects of handbook. WLU'er publication—most expensive publication for WLUSP—is typically intimidating first responsibility for President who has just entered their role. ED often has more experience with publication, would be ideal for them to take on WLU'er publishing responsibility instead of President. Can vote on this today.

**Lifetouch Updates** 

• Lifetouch have sitting fee commission cheque for \$40,794 ready for us, to pay their

outstanding debt. Will finally be able to put this issue to rest and move forward with

Pegasus into next fiscal year.

**Office Move Updates** 

• Office move has been stalled for many months for multiple reasons. Haven't heard back

from Facilities and Asset Management team at Laurier. Will reach out again this month to

inquire about any updates with regards to required renovations for two Albert Street

locations or other opportunities available. Will keep board updated.

President to the Executive Director (i.e., not having to wait for the new President's term

to begin) will give us more time to acquire advertisements.
